SUBJECT: Instructions for FY 2001 SRT Reviews

The schedule for the upcoming sub-regional team (SRT) meetings is attached in Table 1. The purpose for these meetings is to review the projects that have been proposed for funding in FY 2001 and insure that the budgets are in line with the work being proposed. The focus of the review will be on FY 2001 budgets. The review will rely on the technical review performed last year by CBFWA and the ISRP. If objectives and tasks are proposed for FY 2001 that were not reviewed and approved for FY 2000, they may not qualify as ongoing work. Therefore, the first task for the reviewers will be to identify any new objectives and tasks. The second task for the reviewers is to prioritize objectives among the projects to bring the balance for each SRT to that level recommended for funding in FY 2000. I will attend all the SRT meetings and will have a laptop computer for taking notes. Any specific comments you wish to include in the review should be provided at the meeting (electronic format preferred).

The FY 2001 project budget proposals are located on the CBFWA website ([www.cbfff.org](http://www.cbfff.org)) and should be easy to download and print. Also on the website are the FY 2000 proposals that were used for last year's technical reviews. The specific comments from last year's SRT reviews were captured in an Excel table located in Table 6 and 7 in the FY 2000 CBFWA Draft Annual Implementation Work Plan Appendices (also located on the CBFWA website). We can provide CDs at your request that contain all of the information displayed on our website regarding these proposals. If you would like a CD, please email Eric Schrepel ([eric@cbfff.org](mailto:eric@cbfff.org)) and he will forward one as quickly as possible.
