	The MAG accepted the agenda as presented.	
ITEM 2:	Update on Fish Passage Center (FPC) Memorandum of Agreement (MOA) between Pacific States Marine Fisheries Commission (PSMFC) and CBFWA	
	 Brian Lipscomb provided an update advising that Joe Mentor made revisions to the draft MOA focusing on performance management for the FPC Manager. Joe removed any references to policy information or references to the Fish Passage Center Oversight Board (FPCOB). Brian added that future discussions may need to be held regarding the issue of the FPC operating costs. In the past, an MOA was put in place for fish passage inspection with PSMFC. CBFWF administrates the contract but the employee works under PSMFC and PSMFC pays a portion of the salary. There has been discussion regarding the indirect cost (IDC) rate and who is responsible. For this year it was agreed that the previous year savings would cover the cost.

Compact of the Upper Snake River Tribes session does not allow for comment from non-NPCC staff and members but is open for observation.

- Time will be allotted at the April NPCC meeting in Whitefish, MT, to accommodate individual amendment discussions.
- The Council assigned Tom Karier, NPCC, the task of working on the RM&E and data management for the Council to consider for FY09. Tom Karier and Tony Grover, NPCC, will continue to work on strategies and they anticipate working with the agencies and Tribes. They indicated that they will look at CSMEP as a part of their recommendations. They believe that there are elements of CSMEP that need to proceed forward but they don't necessarily agree that CSMEP is the right project.
- The NPCC requested that the Independent Scientific Review Panel (ISRP) provide their expectations relative to the NPCC's M&E matrix. Brian Lipscomb stated that he communicated to the NPCC that he did not feel that was an appropriate question for the ISRP but instead is a question that should be directed to the agencies and Tribes.
- The process for project solicitation was deferred until the April NPCC meeting. Tom Iverson, CBFWA, will provide an update at the March 18th MAG meeting on the elements of what has been developed as directed from the September CBFWA Members meeting. Brian stated that the structural layout is good in that it matches the organization of CBFWA's amendment recommendations; however, the concern is with the 18 month timeline. The positive side of the timeline is that it provides on-the-ground reviews with the ISRP, NPCC, and Bonneville Power Administration (BPA), but the negative is that the process won't be complete in time to inform the rate case. In all likelihood it will result in a rate case that would establish a budget cap and distribution similar to last year.

ITEM 3: Hydro Operations Discussion

Brian Lipscomb, CBFWA, summarized that the resulting expectation for today's meeting was to develop mainstem amendment recommendations detailing operations utilizing the federal BiOp level policy perspective and the non-BiOp perspective.

Chairman Marotz, MFWP, suggested that MAG members set aside concerns and focus on biology and physical environment. Chairman Marotz asked the group to express their expectations and goals and be prepared to discuss strategies to achieve the goals, and determine agreement and discuss alternatives where we have conflicts of interest.

In summary, the group expressed general agreement that there are political and socioeconomic issues that have to be considered but that it may be possible to come to consensus with strategies to mitigate or offset the problems; however, the difficulty would be with regard to the types of specific measures relative to strategic intent.

The recommendation will be reviewed by the MAG on March 18th and then the resulting product from the March 18th MAG meeting will be recommended to the Members on March 19th.
