ITEM 1: Introductions and Approve Agenda

**ITEM 4:** Draft Synopsis of Lamprey Report and Update - <u>Dave Ward, HDR</u>

Engineering, Inc.

The "Draft Synopsis of Lamprey-Related Projects Funded through the Columbia River Basin Fish and Wildlife Program" is a technical summary of existing and past lamprey projects and contains answers to questions requested by the Independent Scientific Review Panel (ISRP). Dave Ward and Christina Luzier (USFWS) will be presenting the draft progress report to the NPCC on March 6 & 7, 2012 meeting.

**Discussion:** Dave Ward, HDR asked if the MAG would approve the draft Lamprey technical

> report as final before it was presented at the March 6 & 7, 2012 NPCC meetings. The majority of the MAG was not in attendance at this time. **ITEM 5: Draft Amended CBFWA Charter**

Foundation staff recommended that the Members should agree on the selection process under Section 403(a) Alternate 1 or Alternate 2 to select officers for Chair and Vice-Chair of the Authority Members. The MAG reviewed the Members draft agenda and requested updates on the

**ITEM 8:** Review Talking Points Regarding Comments on Resident Fish, Data

Management, and Regional Coordination Category Review

At the February 15, 2012 MAG meeting, Tom Iverson provided a presentation Background:

summarizing the ISRP's preliminary "Resident Fish, Data Management, and

Regional Coordination Category Review".

Several members and staff are concerned and confused by the Independent Scientific Review Panel's (ISRP) comments and policy guidance requests.

At the February 15<sup>th</sup> meeting, the MAG decided not to respond to the ISRP review, but to create talking points and possibly meet with Tony Grover and NPCC staff to ask what they plan to do with the ISRP's comments. The talking points identify the concerns that ISRP raised and the fish and wildlife managers' concerns with the

review by the ISRP.

**Discussion:** Tom Iverson presented the draft talking points as a handout that outlined the concerns initiated by the ISRP's comments. Gary James requested the last bullet on the first page be revised.

> At this time, no response to the ISRP is necessary and the NPCC is not requiring comments, but the Resident Fish Focus Group, Northwest Habitat Institute, StreamNet, and Columbia River Inter-Tribal Fish Commission are providing comments.

> Tom I. suggested saving the draft talking points and waiting until the NPCC has released their project recommendations before the MAG takes further action.

"The Council is accepting comments through May 4, 2012, on the ISRP's recently released Resident Fish, Data Management, and Regional Coordination Category Review: Preliminary Review of Proposals, document ISRP 2012-2." See information at http://www.nwcouncil.org/fw/budget/2013/responsetoisrp.asp.

"The Council is in the process under Section 4(h)(10)(D) of the Northwest Power Act to review project proposals related to Resident Fish, Data Management, and Regional Coordination to implement the Council's Columbia River Basin Fish and Wildlife Program. The ISRP's Preliminary Report is available for public comment and is the first of two ISRP reports in this review that you will be able to comment on. The final ISRP report will be available and posted on the Council's website on April, 4, 2012. The comment period will be held open to May 4, 2012, to allow for an opportunity to comment on that report."

"The Council intends for its Fish and Wildlife Committee to consider the project proposals, the ISRP's reports, and the public comments at the Council's May 8 and 9, 2012 meeting in Hood River, Oregon. There may be an additional opportunity for oral comment to the Committee at that meeting, and possibly an opportunity for public comment on a draft set of project recommendations to Bonneville as time allows. The Council then anticipates making final project recommendations to Bonneville on all the project proposals in these categories at the Council's June 12 and 13, 2012 meeting in Missoula, Montana."

## ITEM 9: Status of the Resources (SOTR) Survey Results

In February, a nine-question survey was created to help evaluate usage and content of the SOTR website and assist Foundation staff in continuing to update the user-designed website. The survey was distributed to a broad range of entities throughout the Columbia River Basin requesting users of the SOTR to complete the survey by March 1, in an effort to continue to address the needs and desires of the user group.

Neil Ward provided an <u>overview</u> of the survey results and indicated that the respondents' answers indicate that the Foundation has been successful in creating and maintaining a comprehensive and easy to use website populated with up-to-date data. The broad group of users reported a high level of satisfaction while indicating that they would like to see more data (e.g. habitat status and trend, VSP, resident fish HLIs), data from other programs, and data reviews. Neil's recommendations for the SOTR in 2012 are to: 1) include resident fish high level indicators, 2) facilitate reviews of the data by the technical focus work groups, and 3) evaluate the availability of additional VSP data.

To ensure the website remains up-to-date, Neil and Binh Quan will continue to update the SOTR website on a monthly basis.

It is expected that the final survey report will be available by the end of March 2012 at which time it will be available on the SOTR website.
