ITEM 1: Review and Approve Agenda

Action: Agenda was approved with one addition (i.e., ITEM 3, Election of a New Vice-

Chair)

ITEM 2: Approve Action Notes from the July 14, 2009 and August 11, 2009 RFAC

Meeting

Action: The action notes for the July 14, 2009 and August 11, 2009 RFAC meetings were

approved.

ITEM 3: Election a New Vice-Chair

Effective October 1, 2009, the Coeur d'Alene Tribe (Ron Peters) will become the Chair of the RFAC. To fill the soon to be empty Vice-Chair position, the RFAC

requested nominations and volunteers.

Action: Participants nominated and approved Oregon Department of Fish and Wildlife

(Christine Mallette) as the Vice-Chair for 2009-2010.

ITEM 4: Resident Fish Loss Assessment Letter for Members Review

During the September Members meeting, there was a motion to approve the resident fish loss assessment letter; however, the motion did not receive a second. Sheri Sears and Neil Ward briefed the committee on the actions the RFAC needs to

take to ensure the proposed methodology for assessing inundation losses is

approved by the Members in October and forwarded to the Northwest Power and Conservation Council (NPCC). The RFAC participants acknowledged the importance of briefing their Member representatives prior to the meeting and

requested that the letter be made available far enough in advance to resolve, before

the Members meeting, any concerns that may exist.

Action: The RFAC directed Neil Ward to ensure that the agenda for the October Members

included the following agenda item description "Resident Fish Habitat Loss

Page 2 of 2

Assessment Methodology and Letter for Members Approval." The RFAC also requested that the "Recommended Action" include the similar language.

Action: For the purpose of clarification, the RFAC provided additional (see

highlighted/underlined text in the attachment) verbiage to the letter.

Action: *Neil Ward and Sheri Sears will prepare a PowerPoint presentation that consists of*

few slides that provide the context for the exercise, general description of the

method, and importance of submitting the letter to the NPCC.

ITEM 5: Resident Fish Losses: Development of Methodology to Assess Operational

Losses

Participants continued to review and discuss the existing methods for assessing resident fish losses that are a result of Federal Columbia River Power System operations. Christine Mallette updated the participants on the results of ODFW's review of the MFWP's methodology for evaluating losses associated with the construction of Bonneville Dam. Based on ODWF's initial review, the MFWP's method has limited potential for the use in the Lower Columbia River reservoirs. In addition, Dave Statler suggested that the RFAC should consider some of MFWP's other reports to better understand how MFWPs estimated fishery losses. The RFAC suggested that Brian Marotz should be invited to the next meeting to provide another discussion regarding the MFWP's methodology. Also, Sheri Sears discussed an approach that she has been considering that is more of an ecosystem approach, similar to the approach that the Kootenai Tribe of Idaho is investigating.

Action: Neil Ward will ask Brian Marotz to attend the next meeting as well as provide the documents that Brian referenced during his presentation to the RFAC in Whitefish

in July 2007 (see attached document)

Following the meeting, David Parrish (IDFG) provided IDFG's "Assessment of Fisheries Losses in the Upper Snake River Basin in Idaho Attributable to Construction and Operation of dams with Federal Hydropower Facilities." This report has also been attached for your review.
