- ITEM 1: Review of Agenda
- Action: Yakama Nation HEP Field Work Assistance, Approval of Crediting Subcommittee Report and FY 2000 Funding for Eagle Lakes were added as items 7,8 and 9.
- ITEM 2: Election of New Chair
- Action: Michele Beucler was selected as the new Wildlife Caucus Chair beginning October 1, 1999. Ray Entz will serve as Vice-Chair.
- ITEM 3: MSG Update
- **Discussion:** Ray summarized the actions relative to WC interests from the August 4, 1999 MSG Meeting.
- ITEM 4: M&E Subcommittee Report
- **Discussion:** Presentation of the M&E Computer Model was deferred until the September meeting. Robert Walker presented the final draft of the M&E Report for Caucus review.
- Action: The Caucus approved spending up to \$10,000, of the approximately \$175,000 reserved for M&E, to cover the cost of initial modeling efforts. This is expected to cover development costs through the prototype stage.

ITEM 5: Discussion of Council's Process for FY 2000 Proposals with Conflicting Recommendations from CBFWA and ISRP

Discussion: Peter Paquet discussed the proposed process for dealing with project proposals that had conflicting recommendations from CBFWA and ISRP. This process is described in the August 16, 1999 Version 3 Memorandum from the Council's fish and wildlife staff.

ITEM 6: Discussion of Council Staff Proposal for FY 2001 Procurement Process

Discussion: Peter presented the information also contained in the August 16, 1999 Version 3 Memorandum from the Council's fish and wildlife staff on the FY 2001 Procurement Process and stated that the fish and wildlife manager's role in this new proposed process is still under discussion. Frank Young distributed a draft response to this memorandum developed by Authority staff for consideration by the Authority Members at their August 31 - September 1, 1999 meeting in Portland.

ITEM 7: Yakama Nation HEP Field Work Assistance

Action: Tracy Hames reported that the planned August HEP field activities for his project had been completed successfully thanks to the positive assistance he had received from other Caucus members. He expressed his appreciation to the following people for their assistance: Paul Ashley (WDFW), Brian M. Auld (KT), Susan Barnes (ODFW), Darren Holmes (KT), Steven Lewis (USFWS), David Nunn (SYCD), Brooke Palmer (USFWS), Bill Stewart (USFWS), Haace St. Martin (BPT), and Richard Temple (retired rancher from Burns).

ITEM 8: Approval of Crediting Subcommittee Report

- **Discussion:** Ray Entz distributed an Executive Summary of preferred recommendations from the Crediting Subcommittee's Issue Paper, which was discussed and modified by the Caucus. In addition, the original Crediting Issue Paper was reviewed and modified in response to recommendations from the Caucus.
- Action: The Executive Summary was approved as modified to send from CBFWA to the Council. The Crediting Issue Paper was approved as modified to act as a supporting document to the Executive Summary.

ITEM 9: Funding for Reallocation for FY 2000 Projects

Action: It was determined that since the USFWS had not used up their Interim Agreement funds that they were not eligible to receive the \$287,500 allocated by the Caucus for the Eagle Lakes Project. It was further agreed that the \$287,500 would be distributed among the remaining projects on the prioritized
