ITEM 1: Review and Approve January Agenda

**ACTION:** The January agenda was approved as written.

ITEM 2: Approve December 10-11, 2007 Action Notes

**ACTION:** The December Action Notes were approved as written.

ITEM 3: Letter from WAC to NPCC regarding IEAB tasks 116 and 117

Discussion: The original intent for this ITEM was to finalize the draft letter to the WAC

regarding the IEAB Tasks #116 and #117. Subsequently the WAC learned that the NPCC was to consider, at the January 15 Council meeting, sending a letter

to BPA recommending that some recommendations of the reports be

implemented. The WAC was concerned that the some of the reports' economic recommendations were going forward without consultation with the fish and wildlife managers as to the biological and logistical ramifications of the

recommendations. The WAC was also concerned that the recommendations in the draft letter were taken out of context of the reports.

The WAC would not be able to get their letter approved through the Members of CBFWA prior to the council meeting. Therefore it was decided that the WAC send a memo to the Members of CBFWA suggesting the Members ask the Council to postpone approving the letter until the recommendations in the letter to BPA were discussed with the fish and wildlife managers.

Discussion on this item was continued on January 8. The WAC benefited from having Karl Weist and the Oregon Council members join the conversation by phone so the WAC could discuss their concerns with them. The Oregon Members pointed out that in addition to the memo, if the WAC had concerns the members of CBFWA should voice those concerns to their individual Council members prior to the Council meeting and be prepared to discuss the matter with the Fish Committee at the Council Meeting.

**ACTION:** 

The memo was then prepared. Ken MacDonald will get the memo put on CBFWA letterhead for Angela Sondenaa's signature on January 9 and distribute the memo to the members of CBFWA and post on the WAC website. WAC members were encouraged to have their organizations contact appropriate Council members.
