ITEM 1: Introductions and Approve Agenda

Discussion: The group agreed that the agenda looked complete and adequate for the time

allowed.

ACTIONS: The agenda was approved as written.

ITEM 2: Review and Approve as Final March Draft Action Notes

ACTION: The WAC approved the March 16, 2011 Action Notes as final with no

modifications.

ITEM 3: Wildlife Area Management Plan Template

Discussion: David provided a Plan update. The committee members discussed opportunities to

include many of the sections outlined by BPA as "Appendices", where the Plan body should be devoted to items more along the lines of desired future conditions, management actions, etc. The WAC asked for additional input from BPA about the

use of these potential appendices.

ACTION: Tom will post the BPA draft template to the WAC website for this meeting and

notify the WAC. The WAC will review the draft outline and provide comments and edits to Tom within 2 weeks. Scott and Tracy will meet with David and other BPA representatives and revise the template in time to provide an update for the

next WAC meeting.

ITEM 4: CBFWA Satisfaction Survey Results

Discussion: Tom presented results from the 2011 CBFWA Satisfaction Survey as they directly

related to the WAC. The presentation is available on the WAC website. In general, CBFWA serves a very small but focused community in regards to wildlife. The committee and staff appear to be performing to everyone's satisfaction, with a

few exceptions.

ITEM 5: Wildlife Crediting Forum

Discussion: Peter Paquet requested additional review of crediting forum wrap up document.

Peter was asked for a final table of all the wildlife management areas to recreate these maps and make that information available via the SOTR website. The Council's F&W Committee will review the draft report at their next meeting. The WAC voiced concern that draft document did not have an Executive Summary. The WAC requested that an executive summary be added to the report as a bare

minimum. No formal action was taken at this time.

ITEM 6: Regional HEP Team – 2012 and Beyond

Discussion: The WAC discussed the role and tasks for the Regional HEP Team (RHT) during

2012 and beyond. Discussion topics included the future of RHT, timeframe for implementation, schedule for follow-up HEPs, scope needs to be defined, discussed funding two teams versus one, need for RHT to assist managers in interpret data/tables in HEP reports (clarification reference), and possible summary definitions. Discussed the need for short-term direction/timeframe to construct

2012 contract. The WAC recommended a three year work plan, clarifying the side boards in a new contract to allow for future data collection, build justification for work and provide some stability, determine what funding level is necessary, and

assess BPA management buy-in.

ACTION: Paul will develop a matrix of WMA sites that may require HEP surveys in the next

three years, including potential new acquisitions, anadromous fish acquisitions, and properties needing follow-up surveys. Based on that list, Paul will develop a three year work plan for up to two survey crews to maintain the HEP Team's "lifting power" and to complete all survey reports in a timely manner. The work plan will

be presented to the WAC at their July meeting.

ITEM 7: Wildlife High Level Indicators and Monitoring Implementation Strategy

Discussion: Scott discussed the Upper Columbia United Tribes (UCUT) habitat types being

used by the UCUT Wildlife Monitoring and Evaluation Project (UWMEP) and reviewed HLI information from previous WAC meetings and workshops. The WAC discussed the possible need for a summary of HLI accomplishments to better

define future discussions.

ACTION: Scott will work with Tom I. to re-draft the Wildlife Monitoring Strategy work plan/

timelines and Tom O. to summarize possible HLI parameters. WDFW will provide better methodologies/definitions of their "Cross-walking HEP Data" presentation related to 08/2010 WAC meeting. An update will be provided at the July WAC

meeting.

ITEM 8: Next WAC Meeting

The next WAC meeting will held in Oregon on July 26-27, 2011. Tom will work with ODFW to provide a site visit to Willamette River properties on July 26 and the WAC meeting will be held in Eugene, Corvallis, or Portland on July 27.
