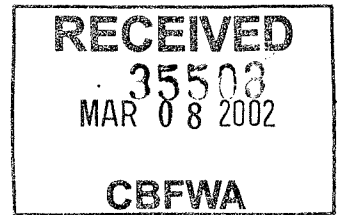

Dear Chairman Cassidy:

Enclosed are our funding decisions on the Columbia Plateau Province fish and wildlife mitigation and recovery proposals submitted through the Northwest Power Planning Council's (Council) Provincial Review. As you recall, on October 16, 2001, we sent you our comments on these proposals for your consideration as you developed funding recommendations to Bonneville Power Administration (Bonneville) for funding in fiscal years (FY) 2002 through 2004. In developing our comments, we focused our review on new proposals and on-going projects intended to benefit anadromous fish and bull trout. Our review also attempted to integrate the fish and wildlife mitigation needs identified in the Council's Fish and Wildlife Program with the needs of Bonneville regarding implementation of the National Marine Fisheries Service's (NMFS) and U.S. Fish and Wildlife Service's (FWS) 2000 Biological Opinions on the operation of the Federal Columbia River Power System (FCRPS).

We hope that our initial comments were helpful to the Council. On November 8, 2001, the Council adopted their funding recommendations and on December 3, 2001, they were posted on the Council's web site.

Since that time, my staff has reviewed the Council's recommendations and had several discussions with Council staff regarding project-specific issues. We concur with the vast majority of Council recommendations. However, Bonneville intends to fund a few new proposals that were not recommended by the Council, but, because of an immediate need, would allow Bonneville to take actions that address specific Reasonable and Prudent Alternatives (RPAs) or measures in the NMFS' and FWS' 2000 FCRPS Biological Opinions as described in the Action Agencies' Annual Implementation Plan. Bonneville's project-specific rationale can be found in the attached enclosure. These new proposals are:

- a. Proposal No. 25049 - Numerically Simulating the Hydrodynamic and Water Quality Environment for Migrating Salmon in the Lower Snake River - \$207,360.

- b. Proposal No. 25053 – Evaluate Bull Trout Movement in the Tucannon and Lower Snake Rivers - \$81,626.
- c. Proposal No. 25062 – Growth Rate Modulation in Spring Chinook Salmon Supplementation - \$345,088.
- d. Proposal No. 25064 – Investigating Passage of ESA-Listed Juvenile Fall Chinook Salmon at Lower Granite Dam During Winter when the Fish Bypass System is Inoperable - \$176,000

In addition, there are a few wildlife projects that were recommended for funding by the Council that Bonneville feels should await either development of subbasin plans, resolution of wildlife crediting issues, or should have only the O&M phase of the on-going project funded, i.e., no new land acquisition or habitat enhancement work at this time. Bonneville's project-specific rationale can be found in the attached enclosure. These projects are:

- a. Proposal No. 25078 – Acquire Anadromous Fish Habitat in the Selah Gap to Union Gap Flood Plain - \$875,000.
- b. Project No. 1992-062-00 – Yakama Nation Riparian/Wetlands Restoration - \$1,416,580.
- c. Project No. 1995-060-01 – Protect and Enhance Wildlife Habitat in Squaw Creek Watershed - \$212,164.
- d. Project No. 2000-023-00 – Securing Wildlife Mitigation Sites (Phillipi and BAIC properties) - \$200,000.
- e. Project No. 2000-026-00 – Rainwater Wildlife Area - \$289,255.

In addition, there are two specific projects, one new and one on-going, that need further clarification. They are proposal no. 25025, YKFP - Secure Salmonid Spawning and Rearing Habitat, sponsored by the Washington Department of Fish and Wildlife (WDFW), and Project no. 1997-051-00, Yakima Side Channels, sponsored by the Yakama Nation (YN). Both of these projects requested about \$2.3 million for FY02, yet some of the properties targeted for acquisition appear in both projects.

Bonneville will not obligate FY02 funds for the purchase of any new properties under either project until agreement is reached among WDFW, YN, the Council and BPA regarding the priority and timing of parcel acquisition under both projects, i.e., agreement on Proposal No. 25025 parcels of Crystal Springs (\$1,000,000), Gold Creek Bull Trout (\$500,000) and Project No. 1997-051-00 parcels of the Dalle property (\$241,000), the Browitt property (\$210,000), and Scatter Creek Phase II property (\$2,044,232). We note that in acting on the Council's initial


funding recommendation of \$565,136 for FY 02 for the Yakama Side Channels, a portion of these FY02 funds have been obligated for the purchase of Scatter Creek Phase I properties.

The enclosed table presents the Plateau projects that appear in the Council's December 3, 2001, recommendations. The table identifies the Council recommended budget and also indicates whether or not Bonneville intends to fund the projects. Relevant comments are included for clarification of our rationale. Where Bonneville suggests a different FY02 budget, estimates of FY03 and FY04 funding levels are not presented but will be negotiated over the course of the fiscal year with Council staff. Otherwise, at this point, Bonneville is assuming the same out-year budgets as has the Council, recognizing the potential for out-year budget changes based on changing Basin-wide priorities, as influenced by the Endangered Species Act and Subbasin Planning.

Again, we have used our best efforts to prioritize Bonneville-funded fish and wildlife mitigation and recovery projects in the Columbia River Basin given the ecosystem (All-H) approach to mitigation and recovery that is being implemented and given that the amount of desired funding for such an approach exceeds that which is available. We want to ensure for our ratepayers that fish and wildlife mitigation and ESA-focused recovery funding is going to those projects that provide the greatest biological benefit at the least-cost.

We hope that this information is helpful and, as always, are willing to discuss any issues that you may have with our decision for project funding in the Columbia Plateau Province. Please give me a call if you have any questions.

Both proposals would qualify under those criteria. Oregon has proposed a habitat acquisition placeholder for the Columbia Plateau province in the Oregon subbasins and developed a prioritized list for acquisitions. The BAIC tract ranks first; the Phillippi property ranks third. The Council would also have to be willing to recommend the proposals in light of the uncertainty regarding Bonneville's crediting response as discussed in General Issue 5."
