At their January 21-22, 2009 meeting in Boise, the Members assigned the AFAC to work with the MAG to develop strategies to (1) identify how the 5 million fish goal was established by the Northwest Power Planning Council (Council) for the 1987 Fish and Wildlife Program, (2) summarize how current objectives have been established, and (3) develop criteria for establishing population goals (including broad sense recovery).

The AFAC discussed a draft memo addressing part (1) of the assignment on February 24th. Dave Ward indicated that he could prepare a draft of part (2) by the next teleconference, at which time the AFAC could discuss the entire assignment.
